



## DESCRIPTION

Bundle D is within two different municipalities of North Lauderdale and Margate. The future land use is primarily residential with a few commerce and community areas. There are a handful of community features such as parks, schools, City Hall and a library which attracts users to this area. Margate Activity Center is within Bundle D. These activity centers as defined from the Broward County Land Use Plan of the Broward County Comprehensive Plan supports a high quality live, work and play community for residents and businesses, including viable multi-modal transportation choices. Seven proposed projects were identified along with Rock Island Road FPL R.O.W. Trail for Bundle D.


## PROJECT LOCATION




### Demand for Active Transportation
