The Complete Streets Master Plan Project Advisory Committee (PAC) met on Tuesday, October 17, 2017, for its third meeting to discuss the progress and the next steps to be taken.

What funding sources can be used for Complete Streets projects?

- The draft Master Plan Prioritization Criteria is consistent with the Goals and Objectives established in the Commitment 2040 LRTP and builds upon the format and content of the CSLIP Evaluation Criteria.
- The draft Master Plan Prioritization Criteria was thoroughly discussed for each of the criteria.
 - Consider changing the Activity Center designation to be based on the <u>Broward County Land Use Plan of the Broward County</u> <u>Comprehensive Plan</u>.
 - Request for Transit Ridership and the Total Activity County (2016 Annual Average Daily Traffic (AADT)) ranges to be reorganized.
 - Incorporate Health in the Prioritization Criteria and if so, distinguish Transportation and Health.
- Proposed Lane Elimination Coordination should encompass a review of Planned Projects, Street Network Impacts, and Planning Impacts in close proximity to the proposed project. The review crosses municipalities and county boundaries if needed.
