# COVID-19 PROTOCOLS

The Safe Streets Summit (The Summit) remains committed to ensuring the health, safety, and well-being of all attendees and presenters. In order to provide a safe learning environment for all participants, we have implemented the following COVID-19 safety protocols which all participants must abide by:

- **Masks:** All attendees are required to wear masks while in the conference space including registration areas, ballroom, Sky Lawn, bathrooms, hallways, and elevators, regardless of vaccination status. The mask should fit tight over the nose, mouth, and chin with no large gaps on the outside of the face. Masks can be removed for drinking and eating but must be placed back on as soon as drinking and eating are complete. Staff will be onsite to enforce the mask requirement. However, any attendee who cannot wear or has difficulty wearing certain types of face coverings, or cannot effectively communicate with others who wear a mask due to a disability or who need a religious accommodation should contact staff for alternative options.
- **Lunch:** To prevent crowding, individual boxed lunches will be provided in lieu of a buffet meal. Attendees will have the option of taking their lunch to the “Sky Lawn”, a 30,000 square foot outdoor turf space. Participants can also choose to take their lunch outside of the hotel if they prefer.
- **Elimination of programs and conference bags:** Programs will be accessed from The Summit’s website as well as by scanning QR codes provided throughout the conference space. The Summit will move forward with paperless programs to both reduce contact and promote sustainability. Additionally, conference bags will not be provided to reduce contacts/exchanges.
- **Registration Check-In:** The Summit is working to implement a contactless registration check-in process that will also reduce crowding.
- **Seating:** Attendees are requested to keep their same table and seat (fixed seating) throughout The Summit.
- **Sanitation:** Individual hand sanitizers will be available for participants at each table. Please take one and keep it to sanitize your hands throughout the day. Sanitation stations will be available throughout the hotel as well. Sanitizer wipes will be available at each table so attendees can wipe down their chairs and tables as needed. We are working closely with The InterContinental to implement cleaning and sanitation

standards that meet or exceed those set forth by the Centers for Disease Control and Prevention (CDC).

- **Physical Distancing:** A maximum of four attendees are allowed at each table. Attendees must follow CDC Guidelines for Physical Distancing while inside, if possible, which means staying at least six (6) feet apart. Attendees must indicate their physical distance comfort level by utilizing the appropriate signifier provided at each table. A palm card explaining the comfort levels will be provided at each table.
- **Temperature Checks:** Temperature checks may be provided upon arrival in the morning and in the afternoon upon return from lunch.
- **Sponsors’ Exhibit:** Sponsors’ booths will be spread out.
- **Health and Safety Signage and Messaging:** Signage will be displayed throughout the venue to remind attendees and presenters of the importance of wearing masks, frequent hand washing, and physically distancing. Verbal reminders will also be provided throughout The Summit.
- **Feeling Sick? Please Stay Home!** If you have experienced any COVID-19 symptoms, have been exposed to someone who has tested positive for COVID-19 five days prior to The Summit, or have recently tested positive for COVID-19, we request that you refrain from attending or presenting for the health and safety of all and to prevent the spread of COVID-19.

We are closely monitoring the COVID-19 pandemic and will provide any changes to participants as needed. *The Summit reserves the right to require a negative PCR test result if health officials indicate a continued increase in cases. **The Summit strongly encourages attendees to test for COVID-19 prior to attending The Summit.***



# WHAT ARE WE DOING?

## Miami-Dade Transportation Planning Organization (TPO) *MiamiDadeTPO.org*

The Miami-Dade TPO continued moving forward with the implementation of the Strategic Miami Area Rapid Transit (SMART) Plan. To date, Locally Preferred Alternatives (LPA) have been adopted by the TPO Governing Board for the Beach Corridor, East-West Corridor, North Corridor, Northeast Corridor, and the South Dade TransitWay. A groundbreaking was held for the South Dade TransitWay bus rapid transit (BRT) service that will provide high-quality service operating with similar features to rail. Virtual Charrettes were also held for the East-West Corridor’s land use scenario planning process. The SMART Demonstration Program now has 34 projects focusing on increasing first and last mile access to existing and future SMART Plan transit stations. The Miami-Dade TPO Urban Mobility & Non-Urban Core Task Forces initiated SMART STEP (Street Transportation Enhancements Program) with eleven projects countywide facilitated by interagency coordination, innovation, and accelerated implementation of pedestrian and bicycle improvement projects that increase connectivity and enhance safety. The TPO was awarded the Tom Bradley Leadership Award, Outstanding Elected Official Leadership Award, Innovations in Planning for All Ages Award of Merit, Outstanding Overall Achievement for a TMA Honorable Mention, and Taste of Transportation Virtual Lunch Series Honorable Mention.

## Broward Metropolitan Planning Organization (MPO) *BrowardMPO.org*

This past year, the Broward MPO was awarded the coveted 2021 Roadway Safety award by the FHWA and Roadway Safety Foundation for the Complete Streets Master Plan, implementation of the Wilton Drive project and Walking Audits Program. The MPO established Broward’s first Tactical Urbanism Program (BTactical) and executed its first pilot project in the city of Deerfield Beach with the support of AARP. The MPO continues with the implementation of the \$400 million investment in Complete Streets. 12 projects (totaling \$50 million) were completed, adding 31 miles of multimodal facilities. In addition, the MPO rolled out an Educational Messaging campaign to provide regular updates on construction status for multiple projects along with important information about the benefits these projects bring to the community. The MPO developed innovative methods to continue to provide training and engage community members in physical activity while ensuring the safety of staff, community members and partners. Multiple training sessions were held virtually emphasizing upcoming and recently established efforts, such as the Open Streets program. Community engagement events, such as Let’s Go Biking! morphed into a month-long virtual challenge allowing participants to experience various facilities in the entire County.

## Palm Beach Transportation Planning Agency (TPA) *PalmBeachTPA.org*

The Palm Beach TPA continues to prioritize Complete Streets projects and initiatives that increase safety and encourage safe, efficient, and connected multimodal transportation. In 2021, the TPA updated its Vision Zero Action Plan to develop a data-driven decision-making framework and create targeted countermeasures along with measurable action items to reduce fatalities and serious injuries. Included is an action of reviewing all fatal pedestrian and bicycle crashes and providing summaries and potential countermeasures on a quarterly basis. Additionally, the TPA led five Walk Bike audits in 2021 to identify pedestrian and bicycle issues by being on the ground and experiencing the built environment firsthand. The TPA’s Transportation Improvement Program (TIP) includes approximately \$125 million for approximately 50 projects over the next five years to substantially improve pedestrian and bicycle infrastructure. In addition, the TPA has prioritized approximately \$35 million for local transit projects. Lastly, TPA staff completed a video about Complete Streets projects in Palm Beach County, how they work and why they are important for the future of our infrastructure landscape. The Palm Beach TPA continues to work with our 39 municipalities on existing Complete Streets projects while identifying new Complete Street opportunities.

**THE HONORABLE DANIELLA LEVINE CAVA**  
MAYOR, MIAMI-DADE COUNTY

Daniella Levine Cava was elected Miami-Dade County's first-ever woman Mayor in November 2020. She enters the Mayor's office following a 40-year career as a relentless advocate for South Florida families in public service and elected leadership. Mayor Levine Cava's administration is focused on building a stronger, more inclusive, more resilient Miami-Dade: prioritizing reforms to make our county safer and prevent gun violence through the Peace and Prosperity Plan; restoring and reinvigorating a thriving economy that delivers economic security for Miami-Dade businesses and families and attracts new industries; saving Biscayne Bay and building and protecting our environment; and directly engaging with residents to make local government more responsive, transparent, and accountable.

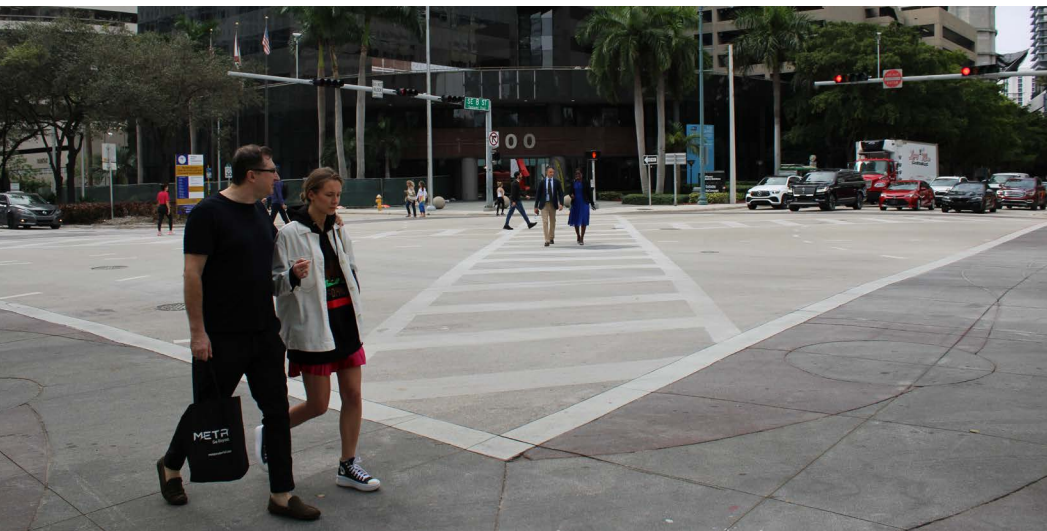

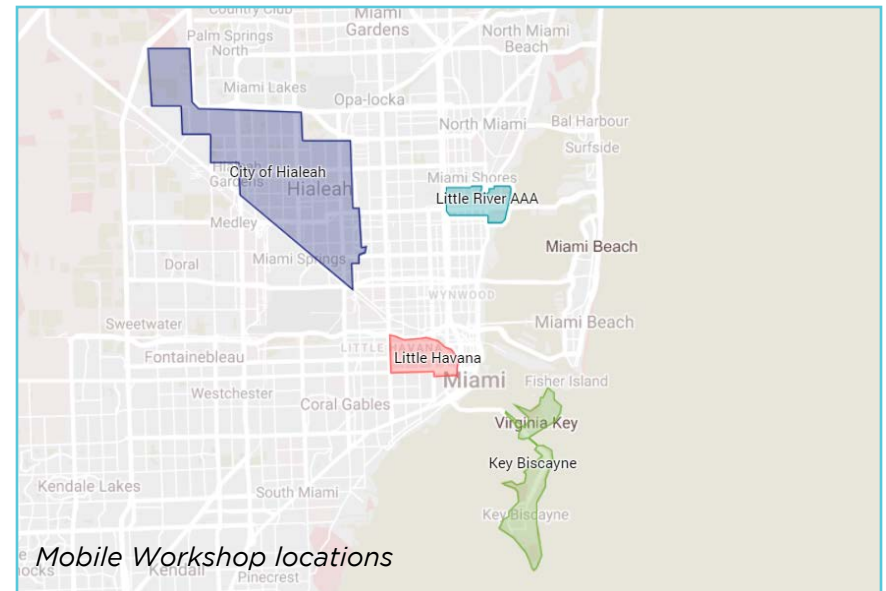


# PROGRAM

As part of the 2022 Safe Streets Summit, there will be multiple interactive tours conducted through the Mobile Workshop event on February 17, 2022. 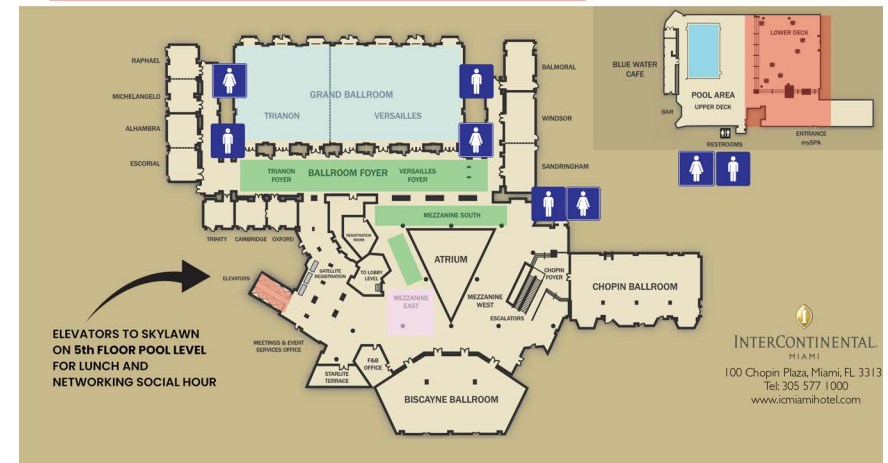

Gabe Klein has been visiting South Florida since the 1980's when his grandmother lived in Aventura and golfed daily at the Turnberry Club. He lived in Las Olas in the 90's. He has worked on plans and strategies including the [Southeast Florida 2045 Regional Transportation Plan](#) and with elected officials and councils in the region after his book, Start-Up City, was published in 2015. Thus, Gabe has watched the region evolve, grow, and as a result face challenges in land-use, mobility, equity, and resilience. Gabe's belief is that challenges are just opportunities waiting for innovative people and resources to solve them. In this Opening Keynote, Gabe will walk participants through his philosophy around how to overcome the disbelief that change can happen, aligning the outcomes, incentives and interests of public and private to make big changes, fast, and how to market pragmatically the future that we know that the South Florida region needs, and deserves. 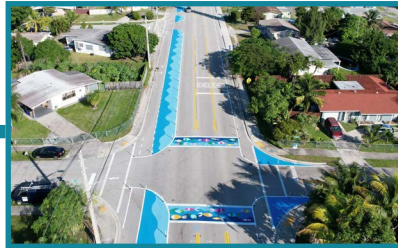
