WHAT ARE WE DOING?

Broward Metropolitan Planning Organization (MPO)

BrowardMPO.org

The Broward MPO's nationally recognized Complete Streets Initiative is changing Broward's streets, making them accessible and safer for all users of the road. The Mobility Program (the implementation arm of the Initiative) made tremendous strides this past year in planning and delivering Complete Streets. Two Complete Streets demonstration projects are currently under construction, and the first group of mobility projects is nearing completion. This brings the MPO's total investment in Complete Streets over the next five years to \$283 million which will add approximately 120 miles of bicycle facilities, in addition to sidewalks and multi-use trails.

MPO staff is working diligently with local partners to implement projects identified in the TIGER grant awarded to the MPO in 2016. Other related efforts include: the Complete Streets Master Plan, the Bicycle/Pedestrian Safety Action Plan, the Complete Streets and Localized Initiatives Program (CSLIP), and the annual Let's Go Walking! and Let's Go Biking! events.

Miami-Dade Transportation Planning Organization (TPA)

MiamiDadeTPO.org

The Miami-Dade TPO is focusing on safety and mobility through the development of the Strategic Miami Area Rapid Transit (SMART) Plan. The SMART Plan will advance six rapid transit corridors, along with a network system of Bus Express Rapid Transit (BERT) service, in order to implement mass transit projects in Miami-Dade County. First and last mile connections will link the SMART Plan facilities to nearby destinations and increase accessibility of the new transit service. Complete Streets are one strategy for creating first and last mile connections and supporting the development of a complete transportation system.

Palm Beach Transportation Planning Agency (TPA)

In the last year, the Palm Beach TPA adopted Complete Streets Design Guidelines to encourage and guide implementation of Complete Streets, and adopted an award-winning, countywide Pedestrian and Bicycle Safety Study. The TPA is nearing completion of its first Health Impact Assessment (HIA) for a Multimodal Corridor Study of a 42-mile stretch of US-1, and plans to incorporate HIAs as part of future corridor studies to promote health and equity in transportation planning.

The TPA continues to deploy pedestrian and bicycle counters and to identify hazardous walking conditions for elementary schools. Future plans include a pedestrian and bicycle access to transit study to identify and propose solutions to connect missing links. The TPA's annual Local Initiatives and Transportation Alternatives competitive funding programs prioritize Complete Streets projects. The Transportation Improvement Program (TIP) includes nearly \$173 million for 44 projects over the next five years to substantially improve local pedestrian and bicycle infrastructure to advance the TPA's Complete Streets initiative.



LOCAL OFFICIALS



Susan Haynie (@SusanHaynieBoca) is the elected Mayor of the City of Boca Raton, serving her seventh-term on the Boca Raton City Council. She has led Boca Raton to prosperity through robust economic development and job creation. In addition to her duties as Mayor, she is the Immediate Past President of the Florida League of Cities, Chair of the Florida MPO Advisory Council Governing Board, Chair of the Southeast Florida Transportation Council and Chair of the Palm Beach TPA.



Jeri Muoio (@jmuoio) was elected Mayor of the City of West Palm Beach in 2011 and re-elected in 2015. She previously served on the West Palm Beach City Commission for four years. Her focus on strengthening the economy has led to the creation of thousands of new jobs. The five-year funding program of the TPA includes more than 3 billion dollars for transportation projects and services. He has more than 20 years of combined experience in the private and public sectors, working in Palm Beach County for the past 15 years to make clear connections between transportation, economic development, and quality of life.

Keynote Session: Leadership to Reinvent Transportation and Infrastructure

The sorry state of American infrastructure affects businesses and everyday lives: commuters stuck in traffic congestion; delayed goods at higher costs; human suffering from collapsing bridges or train derailments; public transit that fails in severe weather or fails to connect poor neighborhoods to jobs; and other weaknesses compared to international competitors. Drawing from her book, "MOVE: Putting America's Infrastructure Back in the Lead," Professor Kanter takes a sweeping look across modes of transportation and changing industries to illuminate the roots of the current system and where the leadership will come from to initiate dramatic improvement to create safe, walkable, bikeable, transit-oriented communities for the future success of cities.

How do safe streets that are walkable and bikeable improve community health and equity? The states with the lowest levels of biking and walking have, on average, the highest rates of obesity, diabetes, and high blood pressure. The negative impacts are most significant in underserved communities where the lack of access to safe and convenient transportation can result in health, social, and economic disparities. Implementing Complete Streets policies has been identified as a tactic to develop more walkable, livable communities where residents can be more active and socially engaged, have improved mental health and have increased access to opportunity and healthy choices. In this session, panelists will highlight the connection between health, equity, and transportation. The sharing of success stories will discuss tools, policies, and practices that can be integrated throughout transportation planning.

He hosts and produces the Sunshine Economy and anchors the Florida Roundup in addition to leading the organization's news engagement strategy. Tom was most recently the co-anchor and managing editor of Nightly Business Report on Public Television.



Peter Kageyama (@pkageyama) is the author of "For the Love of Cities: The Love Affair Between People and Their Places and Love Where You Live: Creating Emotionally Engaging Places." Clinton Forbes (@Palm_Tran) is the Executive Director of Palm Tran Public Transportation. He is a Florida native and has served in the public sector for 29 years, twenty-two (22) of which serving at the senior management and leadership levels at the Miami-Dade Metropolitan Planning Organization and four transit properties. Mr. Forbes also served in Miami-Dade County Mayor's office as Executive Transportation Advisor as part of a team assembled by former Mayor Alex Penelas.

Patrice Gillespie Smith (@DowntownMIA) is the Sr. Manager of the Miami Downtown Development Authority's (DDA) Planning, Design & Transportation department. For the last 20 + years, she has worked as an urban planner across the nation to create more walkable, livable and vibrant communities. Prior to working for the Miami DDA, she managed Neat Streets Miami and helped facilitate the Safer People, Safer Streets Action Plan and the Miami-Dade Complete Streets Guidelines.



Leah Shalum (@visionzeronet) is the founder and director of the Vision Zero Network. The Network helps communities develop and share best practices for safe mobility for all road users. As a German Marshall Fund Fellow, Leah researched Vision Zero strategies in Sweden, Germany and the Netherlands. Prior to that, she was the Executive Director of the 10,000-member San Francisco Bicycle Coalition, which promotes bicycling for everyday transportation.



Jim Curtin (@SeattleDOT) is a Senior Transportation Planner at the Seattle DOT. Jim created Seattle's Safe Routes to School program in 2007 and worked with leadership to set a zero-fatality transportation safety goal for the city in 2012. Jim currently oversees the planning and implementation of SDOT's Vision Zero program.



Carmen Monroy (@myFDOT) is the Director of Policy Planning for the Florida Department of Transportation over the combined Transportation Policy and Planning program areas that include Federal and State Policy, Statewide Transportation Planning, and Metropolitan and Regional Transportation Planning. In her position she also serves as the Chair of the Florida Bicycle and Pedestrian Partnership Council (BPPC). Carmen has more than 25 years of experience in transportation.
