## **Highlights**

#### 2016 TIGER Grant

The Broward MPO has applied for a Transportation Investment Generating Economic Recovery (TIGER) Grant for \$11.4 million for the construction of approximately 9.2 miles of bicycle, pedestrian and greenway facilities that "fill in the gaps" of Broward's bicycle and pedestrian network. These network facilities help to provide crucial multimodal connections to 85 educational facilities and employment centers, civic uses, and other regional destinations which serve the everyday needs of Broward's residents and visitors. Further, these projects will promote safety and will build upon the MPO's Complete Streets Initiative which represents a commitment of approximately \$120 million over the next five years to construct approximately 100 miles of bicycle facilities and



40 miles of sidewalks along Broward's existing roadways. TIGER grant awards will be announced sometime in August or September 2016.

#### **Mobility Program / Complete Streets Initiative**

Through the Broward MPO's Mobility Program, over \$120 million in bicycle and pedestrain improvements (including sidewalks, multi-use paths, and bicycle lanes) have been programmed over the next four years (2016-2020). Under this program, two demostration projects were selected to show the difference between a "Complete Street" located in an urban environment and one located in a suburban setting. Both streets are being designed with the same principles, however, they might not look the same. In addition, the Broward MPO will be collecting before-and-after data related to health, safety and transportation to measure the success of each project. The two Complete Streets demostration projects are: Hollywood Boulevard and Sunset Strip. Both projects are in the latter stages of the Design phase with construction currently scheduled to start in March 2017 for Sunset Strip and July 2017 for Hollywood Boulevard.



#### 2016 Safe Streets Summit



On January 29, 2016, the Borward MPO hosted the 3<sup>rd</sup> annual Safe Streets Summit in the historic city of Deerfield Beach in January. With over 200 attendees, the Summit

was the largest to date, and brought together elected officials, technical staff, and national leaders from various fields. Kit Keller, Executive Director of the National Association of Pedestrian and Bicycle Professionals,

attended the Summit and remarked that it "served as a model for MPOs across the country." At the Summit, participants learned about the planning, design, and implementation of Complete Streets concepts in Broward County, South Florida, and across the nation. Highlighted by keynote speakers Barbara McCann (USDOT) and Charles Marohn (Strong Towns), the 2016 Safe Streets Summit provided training to municipal representatives, consultant staff, state DOT staff and elected officials.
